1. Open Session

a. **Call to Order & Approval of the Consent Agenda,** D. MacLatchy Following the chair's introductory remarks, the Senate heard about two minor amendments to two items in the Report from the Senate Academic Planning Committee. (Secretary's Note: the two changes are noted in the consent minutes below at agenda items 6.a.v., and 6.a.xlv.). The chair confirmed that time for questions will occur under Other Business.

Motion (M.L. Byrne/A. Clarke): that Senate approve the Consent items listed for approval under item 6.a. **Carried.**

b. Leadership Update

- Report of the President, D. MacLatchy
 - D. MacLatchy welcomed Senators to the first meeting of 2024. She offered congratulations and thanks for his leadership to Vice-President: Student Affairs, Ivan Joseph as he retires at the beginning of February, and extended a warm welcome back to David McMurray in that role; she also described some of the upcoming work in that portfolio. The president also

offered thanks to Kalyani Menon for her time serving as the Dean of the Lazaridis School of Business & Economics, and as an ex officio Senator.

In her report about Strategic Action Plan activities, members heard: a reminder that the Laurier Strategy 2019-2024 is in its final year; about some of the institutional- and unit-level plans that have recently been developed; about reporting to government that is undertaken; the goal of finding connections between these plans, operationalizing recommendations, and establishing clear targets with accountability; about the coming conversations with constituencies to inform a Strategic Action Plan with annual reporting; that a draft will be brought to Senate in May; a commitment to transparency and accountability throughout the process.

In an overview of recent government relations activities, Senate heard: what is known at this early date regarding international study permits; that the University is working with sector colleagues to gather information and undertake advocacy work; the new process for the required attestation letters is not in place and backlogs can be expected; that renewals of study permits are not impacted; about some of the discussions taking place; the likely impact on the financial health of the sector; an update on the Blue Ribbon Panel Report (the government's response is still pending; recent work by COU to raise awareness of the sector's value and its financial pressures).

In discussion: some of the potential impact of the international study permit issue to the University; other local matters and impacts, including housing; the number of current international students (as provided at the November meeting, 1,300) and the impression for next year; while Laurier's numbers are not large, the financial impact is significant; the longer-term approach to focus on ensuring Laurier's world class offerings remain an excellent value proposition.

ii. Report of the Provost and VP Academic, H. Northwood

H. Northwood spoke to the past weekend's marking of International Holocaust Remembrance Day and noted today is the National Day of Remembrance of the Quebec City Mosque Attack and Action Against Islamophobia. She reminded Senators of University resources available to them. H. Northwood also reminded members that February is Black History Month, and she noted some upcoming activities, resources and programming will follow. In an overview of key activities, members heard: about the coming Provost's Town Hall on February 5, 2024; some student recruitment updates and her hope that members of the community will do all they can at future open houses to help bring these great applicants to Laurier; leadership updates (including: an expression of tremendous thanks to Kalyani Menon as she steps down as interim LSBE dean; the continuation of Maria Cantalini-Williams [FOE] and Anthony Clarke [FOS]

as deans for one year; that Robert Basso will serve as FSW interim dean for 18 months; some of the upcoming searches); an international update, including some details about the upcoming Joint Senate-Board Education Session being held on February 9th; recent and coming initiatives relating to the Indigenous portfolio, and, the Equity, Diversity and Inclusion Office (including: the Red Dress Initiative on February 14th; that Justice Gethin Edward is joining as visiting scholar); some details of the work of the Generative AI Committee, and of the Brantford 5000 Committee; the approaching deadline for nominations for the Faculty Award for Service Excellence and Community Engagement.

In discussion: regarding the GenAI activity, its goals include finding the right balance, ways it can help, being mindful of pitfalls, and best ways it can be used in the classroom; the benefits of streamlining processes for development of new academic endeavours; the timing of a potential Law School in Brantford; the current complex climate on campuses with regard to academic freedom and freedom of speech and the desire to ensure all community members feel safe.

- c. **Business Arising from the Previous Minutes**, D. MacLatchy There was no business arising from the minutes of the previous meeting.
- d. **Mode of Delivery Courses,** T. McLaren
 In the interest of time, this item was deferred to the March Senate meeting.

2. Reports and Recommendations from Standing Committees

- a. **Senate Executive and Finance Committee,** D. MacLatchy
 - i. 2024-2025 Tuition Fee Report, J. Fraser / R. Reid
 - J. Fraser noted that as mentioned in the president's remarks, the University is awaiting the government's response to the Blue-Ribbon Panel Report. In the meantime, the proposed tuition, program, and course fees are being put forward for recommendation to Senate and the Board for approval. Members heard that if the government makes changes regarding tuition fees, revised tuition fees will be brought to Senate. R. Reid then walked members through the presentation distributed with the agenda.

In discussion: confirmation that sector comparisons, and consultations with international recruitment team members have been undertaken.

Motion (C. Johnston Turner/M. Abu-Rshaid): that on the recommendation of the Senate Executive and Finance Committee, the Senate recommend the Board of Governors approve the 2024-2025 Tuition Fee Report as presented. **Carried with one abstention.**

ii. 2024-2025 Budget Planning Process Update, H. Northwood / L. Noronha

L. Noronha provided an overview of ongoing budget planning activities and noted that final approvals will be sought later in the spring. He spoke to: some of the factors having an impact on the process (the domestic tuition framework, potential changes to grants, caps and other provincial announcements); finding reductions, efficiencies, and other cost containment measures; the significant challenge in balancing the budget.

In discussion: that the community's wellness and minimizing impacts are top of mind.

b. Senate Governance Committee, S. Ramsay

- iii. Meeting Modality Update and ii. Voting Procedures and Rights of Senators
 - S. Ramsay advised the Senate that following careful discussion, and a recognition of the fundamental importance of robust debate, diverse perspectives, decision-making, and effective governance, the Committee recommends that the current practice for votes (first a call for those opposed, then a call for abstentions, then a call for those in favour; use of shows of hands instead of polls) should continue. He further noted that Senators have a responsibility to vote in accordance with their expertise, understanding of the issue at hand, and in the best interests of the University; that Senators have freedom to express their opinions, even where they differ from others; that all Senators shall engage in discourse and debate with respect for differing viewpoints and maintain a collegial and inclusive atmosphere; and that Senators should ask questions to obtain the information they need to make decisions within the scope of Senate's mandate. S. Ramsay also advised that the committee recommends continuing with hybrid meetings for Senate and that its committees will continue to meet virtually.

In discussion: that questions relating to the Senate business at hand are welcome, and that if they are not a Senate matter, they will be redirected; a continuous improvement approach is being taken.

In response to questions, Senate heard: international students revenue in 2022/2023 was \$37.3M, (21% of total tuition revenue and 11% of total operating revenue); the Faculties are working with the admissions team to determine cut-offs given application numbers, applicants' academic records, and program-level enrolment targets; that there is no government grant to the University for international students; at 11% of total revenue, international students do have a significant impact on the budget.
